

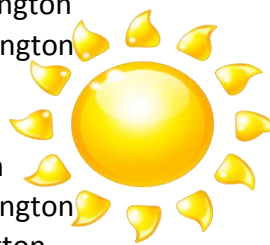
ARLINGTON ISD - SUMMER FEEDING PROGRAM 2011
