AISD Board of Trustees Charge to the Citizens Bond Oversight Committee

The Citizens Bond Oversight Committee ("Committee") is established to provide transparency and enhance public confidence in the use of proceeds from the sale of bonds authorized by Arlington Independent School District ("AISD" or "District") voters on May 10, 2014. The purpose of the Committee is to provide findings and recommendations to the Board of Trustees ("Board") relating to the expenditure of bond proceeds authorized in the 2014 Bond election, the progress of the 2014 Bond program, and ways the District can maximize the potential of the 2014 Bond program.

The Committee shall operate strictly within the charge approved by the Board.

The Committee shall serve in an advisory capacity to the Board and shall not assume the responsibilities or duties of the Board or AISD administration.

The Committee shall be comprised of a maximum of 11 voting members appointed by the Board and non-voting student members consisting of the Board's Student Leader Advisory Board ("SLAB") members. Committee membership may include no more than 1 AISD employee.

Individuals must pay property taxes (residential and/or commercial taxes) to the Arlington Independent School District and be paid current on their property taxes to be eligible for Committee membership. Every application received by the Board shall be given careful consideration. Final selection shall be determined by the Board.

Committee members, their relatives and their employers are prohibited from having contracts or pending contracts with AISD for the 2014 bond program during their term on the Committee.

Committee members shall serve two-year staggered terms. In the year of creation, 5 of the 11 Committee members will be appointed to one-year terms, and 6 of the 11 Committee members will be appointed to two-year terms. Any Committee member who files for election to the Board must immediately resign from the Committee.

Terms may be extended for additional one or two year terms upon approval by the Board.

The Committee shall represent equally all citizens, all students, all school campuses, and all taxpayers within the boundaries of the Arlington ISD.

Individual members of the Committee shall not exercise authority for the Committee as a whole and shall not act independently of the Committee.

The Committee shall operate within applicable AISD policies and regulations and applicable law.

All meetings of the Committee (and subcommittees) shall be open to the public.

The AISD administration shall be available to the Committee as required, but within limitations imposed by the administration's daily duties.

Each Committee member shall be asked to make a firm commitment to attend all Committee meetings, to visit District facilities as needed, and to participate in the formation of reports to the Board. Committee members shall miss no more than two Committee meetings in any calendar year (not including subcommittee meetings) to remain a member of the Committee. Any member who misses three Committee meetings will be automatically dropped as a Committee member and the Board may appoint a replacement.

The Board shall appoint a Committee Chairperson to serve at the will of the Board. The Committee Chairperson and Superintendent or Superintendent's designee shall establish the specific timeline, frequency of meetings, and agendas for the meetings. The Committee Chairperson and Superintendent or Superintendent's designee shall also organize the formation of subcommittees, as appropriate, to research and analyze issues in greater detail. Subcommittees shall operate strictly within the Committee charge approved by the Board.

The Committee may adopt operating rules and may seek advice from AISD employees as appropriate.

The Committee shall meet at least once each quarter to review the bond program expenditures and progress. Additional meetings may be called, as necessary, by the Committee Chairperson and Superintendent or Superintendent's designee (not including subcommittee meetings). In the first year of operation the Committee may hold up to two additional organizing meetings.

Two-thirds of the Committee membership must be present at scheduled meetings in order for the Committee to vote. If less than two-thirds of the Committee membership is present, they shall meet but not vote. All decisions of the Committee shall be made by majority vote.

The Committee shall begin its duties not later than October 2014. The Committee shall provide progress reports, findings, and recommendations to the Board semi-annually or more frequently, if appropriate. The Committee Chairperson may contact the Board at any time.

The target date for completion of responsibilities shall be the first Board meeting in January 2020, or such date at which all scheduled bond projects have been completed. Upon completion of its responsibilities, the Committee shall dissolve unless continued by approval of the Board. The Board may suspend the Committee at any time.

The Board may act upon any interim or final finding or recommendation by approving, amending, altering, or not approving all or any part of the any Committee recommendation.

The Citizens Bond Oversight Committee is charged with the following:

- Review the January 2014 report submitted to the Board by the 2013-14 Capital Needs Steering Committee to gain an understanding of the projects and capital needs recommended for inclusion in the 2014 Bond Program.
- Review the process used to solicit, qualify, and select design professionals and contractors and vendors for projects funded from the 2014 Bond Program.
- Review reports on the current status and planned implementation of the 2014 bond program to determine whether such status and implementation are consistent with the bond program approved by the voters.
- Review bond program reports that track budgets, encumbrances, expenditures, and estimated costs for completion for each bond project.
- Review HUB utilization on facilities projects.
- Review internal and external audits of the bond program to ensure the adequacy of scope, administration's response to the audit, and remediation efforts of the District, as applicable.
- Review and provide input on AISD communications to the public regarding the 2014 bond program.
- With the coordination of the Superintendent or Superintendent's designee, conduct on-site campus and facility visits related to bond projects, as necessary, in a non-disruptive manner.
- Agree by majority vote upon all findings and recommendations to be presented to the Board.
- Provide reports to the Board semi-annually or more frequently, if necessary, on the implementation of the 2014 bond program and any findings and recommendations for corrective actions or adjustments to the bond program.
- Coordinate with the Superintendent or the Superintendent's designee to maintain a presence on the AISD website with a link on the AISD home page. The website shall timely provide the public with information regarding the Committee's activities, including: meeting agendas and minutes; information, presentations and reports received from AISD staff; and meeting schedules of the Committee and all subcommittees.

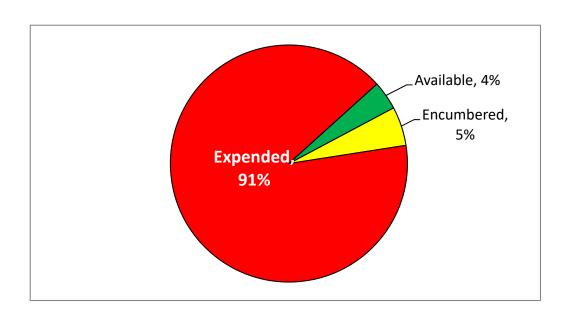

<u>Purpose</u>: To give the Board of Trustees the opportunity to consider and act on Change Order #1 amending the contract amount for 2014 Bond Construction Project for Young Junior High School, Ditto Elementary School, and 5618 Arkansas Lane Renovations Project, Phase V – Bid Package 5.

Background: As a part of the deficiency and life cycle improvements at Ditto ES, the General Contractor, Big Sky Construction (Big Sky), has incurred certain unforeseen costs which cannot be funded through the original, Board approved, construction contract. During the process of constructing the new parking area and tying in new building plumbing the contractor identified that the sanitary sewer and storm water piping serving the building was completely deteriorated and in need of total replacement. Big Sky and their mechanical subcontractor have provided a plan and pricing to remedy the deficiency. Big Sky has submitted Change Order #1 for the Ditto ES renovation project in the amount of \$464,512.46. This change order is comprised of four main items summarized in the table below.

In addition to the cost impact of addressing the unforeseen plumbing issues, there is a need to allow Big Sky additional time to complete the project. The CSP agreement, approved by the Board of Trustees on February 7, 2019, provided for a substantial completion date of August 1, 2019. As such, Big Sky has requested an additional 152 days from the original substantial completion date to complete the project. Big Sky has submitted Change Order #1 to amend the contract amount and a corresponding Notice of Claim to amend the substantial completion date to December 31, 2019

LBL Architects (LBL), the project architect, has reviewed the change order and validated the costs with Big Sky and AISD staff.

Mr. Horn,

There have been several unforeseen existing conditions and owner's requests replacement of exterior and crawl space sanitary and storm sewer lines, and subsequent fees for bonding, insurance, and contractor overhead to the school renovation project which are indicated below. Funds from the Construction Contingency Allowance have been set aside for critical items to keep the contractor working, however the fund is insufficient to cover all the costs for the required modifications and changes.

We have reviewed the contractor's revised cost proposal dated 10-25-19 for the required work and it is acceptable. The change order increases the Original Contract Amount contract amount by \$464,512.46 to a new contract amount of \$6,961,512.46 and adds 152 days to the Substantial Completion date from August 1, 2019 to December 31, 2019.

The five Items to be addressed in the Change Order are:

- 01- Replacement of exterior sanitary and storm sewer line changes necessary to address unforeseen deteriorated conditions in the amount of \$65,284.06.
- 02- Replacement of crawl space sanitary and storm sewer line changes necessary to address unforeseen deteriorated conditions in the amount of \$315,000.00.
- 03- Owner controlled contingency allowance in the amount of \$42,000.00.
- 04- Fees for Bonding, Insurance and Contractor Overhead in the amount of \$42,228.40. This consists of Overhead, Profit, Insurance and Bond totaling 10% of the PCO costs.

Big Sky Construction is submitting this letter to Arlington ISD requesting a change order in the amount of \$464,512.46 and a time extension of 152 calendar days, extending the date of Substantial Completion to December 31, 2019, for added work resulting from unforeseen conditions found on the project. The items included in the change order are as follows:

- 1. Replacement of sanitary sewer and storm water drainage lines under the new parking area due to unforeseen deteriorated lines in the amount of \$65,284.06.
- 2. Replacement of sanitary sewer and storm water drainage lines in the crawlspace under the school due to unforeseen pipe deterioration in the amount of \$315,000.00.
- Owner controlled contingency allowance in the amount of \$42,000.00.
- 4. Fees for bonding, insurance and contractor overhead totaling 10% of the costs in the amount of \$42,228.40

Detailed proposals for the added scopes, including subcontractor pricing, have been provided and reviewed by LBL Architects and AISD Project Managers.

Subject: Change Order #2 Amending the Contract Amount for 2014 Bond Construction Project for Larson Elementary and Lamar High School Renovations Project, Phase IV - Bid Package 5

<u>Purpose</u>: To give the Board of Trustees the opportunity to consider and act on Change Order #2 amending the contract amount for 2014 Bond Construction Project for Larson Elementary School and Lamar High School Renovations Project, Phase IV – Bid Package 5.

Background: As a part of the deficiency and life cycle improvements at Lamar HS, the General Contractor, Imperial Construction (Imperial), incurred certain unforeseen costs which could not be funded through the original, Board approved, construction contract. During the process of replacing sections of the hydronic piping system, the general contractor encountered unforeseen asbestos-containing-insulation which required abatement and replacement. Additionally, unforeseen structural subfloor conditions in the athletic locker room required flooring modifications necessary to support storage utilization. And lastly, in the process of resurfacing the main student parking area, the general contractor encountered unstable subsurface soil conditions which required concrete stabilization prior to placing the new surface material.

The Competitive Sealed Proposal (CSP) #18-74 was approved by the Board of Trustees on August 16, 2018. Change Order #1 was previously approved by the Board of Trustees on April 25, 2019. Imperial is submitting Change Order #2 for the Lamar HS renovation project in the amount of \$264,125.19. This change order is comprised of four main items summarized in the table below.

In addition to the cost impact of addressing the unforeseen issues, there is a need to allow Imperial additional time to complete the project. The CSP agreement provided for a substantial completion date of August 5, 2019. Imperial has requested an additional 148 days from the original substantial completion date to complete the project due to the unforeseen conditions encountered during the project. Imperial has submitted Change Order #2 to amend the contract amount and a corresponding Notice of Claim to amend the substantial completion date to December 31, 2019.

BRW Architects (BRW), the project architect, has reviewed the change order and validated the costs with Imperial and AISD staff.

Pending approval of Change Order #2 the amended contract amount would be \$11,519,955.18.

Brown Reynolds Watford Architects has reviewed the Change Order Request for Lamar High School, dated November 25, 2019, provided by imperial Construction, Inc. We believe the items listed are unforeseen conditions and that the listed value of \$264,125.19 is both fair and reasonable for the work described.

We also have reviewed the Delay Claim submitted by Imperial Construction on November 25, 2019 requesting 148 additional days moving the Substantial Completion date from August 5, 2019 to December 31, 2019. We find that the time required for the approval of the additional Athletic Scope and the long lead items contained therein, the existing conditions of the existing subgrade at the asphalt parking lot not being able to bear the weight of the equipment necessary to make repairs, unforeseen flooring requirements in PE Storage X395, and the lead time to obtain the 4-pipe fan coil units are legitimate delays out of their control.

Therefore, it is our recommendation that Arlington ISD approve the proposed Change Order Request and the Delay Claim by Imperial Construction, Inc.

AISD Lamar High School Delay Claim

The Lamar High School Renovation Project has a current contractual Substantial Completion date set as August 5, 2019. In the paragraphs below, Imperial will provide justification and a formal request of an extension of time to achieve Substantial Completion on this project.

Unforeseen conditions of the existing subgrade, encountered at the asphalt student parking lot, has caused several weeks of delay with an expected completion date in mid-August. The subgrade was in such poor condition that it was not able to withstand the natural weight of the equipment needed to complete the repairs and overlay originally called out in the bid documents.

There has been resolution of a recent design issue that impacted the procurement and installation of the updated 4-pipe Fan Coil Units. The original design called for 2-pipe FCUs to be procured and installed on an existing 2-pipe system, however it was discovered that the existing system is a 4-pipe system. The necessary 4-pipe coils that are required to make this swap out have lead times of 8-10 weeks.

Architectural modifications to the locker room, storage room X395, and the ensemble room have resulted in a delayed installation of flooring in these areas. Material lead times are approximately 4 weeks from date of order placement. Existing subfloors have forced a change in design to accommodate unknown existing conditions that were discovered during the demolition phase of these rooms.

Contractually, Imperial Construction, Inc. was required to achieved Substantial Completion on this campus on August 5, 2019. As a result of the late adjustment in scope, unusually long lead times for materials and the risk mitigation factors explained above, Imperial Construction, Inc. is requesting an additional 148 calendar days (Mon-Sun), to be added on to the current Substantial Completion date. This will make the revised Substantial Completion date December 31st, 2019. The Final Completion date will also be December 31st, 2019.
