## 2025 - 2026 Online Registration is almost here!

Online Registration through Parent Self-Serve will open on April 18, 2025 for the 2025-2026 School year for both New and Returning students.

#### Returning Students

Students who completed the 2025-2026 school year at Martin and incoming 9th graders from Boles JH or Young JH.

Parents will complete the online registration and upload their utility bill dated within 30 days of the day registration is completed. We must be able to see the date and the service address (not mailing address) on the bill. For assistance with password resets and Parent Self-Serve questions, please contact your student's attendance clerk.

#### New Students

Students who moved into Martin's attendance zone or attending on an approved transfer. These students did NOT complete the 2025-2026 school year at Martin, Boles JH, or Young JH.

Parents will complete the online registration and upload all required documents listed below. In-person registration for new students will begin at the end of July 2025. Please check back in the summer for appointment dates and times to meet with the counselors to create a schedule. # 2025-2026 NEW STUDENT REGISTRATION

Log onto www.aisd.net to complete the district's online registration through the Parent Self-Serve portal and upload all required documents. The parent or guardian will then bring the student to the campus to complete the enrollment process on the day the student will start school.

#### **REGISTRATION DOCUMENTS**

- Proof of Residency: Current utility bill (gas, water, or electric), mortgage statement, or lease agreement. (Must be dated within 30 days of registration.)
- Student's Birth Certificate
- Student's Social Security Card
- Photo ID of Parent/Guardian: Driver's License, State or International ID, or Passport
- Photo ID of the Affiant or New Guardian (If applicable)
- Current Immunization Record
- Report Card/Transcript from Prior School, Current Class Schedule

#### **EDUCATIONAL GUARDIANSHIP**

If a student is living with someone other than a parent, an Educational Guardianship must be completed and notarized by both the parent and the guardian.

- Educational Guardianship Form (Spanish)

#### **RESIDENCY AFFIDAVIT**

If a parent or guardian and the student are living with a friend or relative, a Residency Affidavit must be completed and notarized by both parties. Residency Affidavits must be renewed yearly.

- Residency Affidavit Form (Spanish)

Both the Parent or Guardian and the Affiant's name must be listed on the bottom where it says personally appeared indicating the notarization was performed for both parties.

#### REQUIRED IMMUNIZATIONS

- Diphtheria Tetanus/Pertussis: At least 3 doses, with one since age 4
- Tdap/Td booster 1 dose within last 10 years
- Polio: 3 doses, with one since age 4
- Measles, Mumps, Rubella: 2 doses

- Hepatitis A: 2 doses required K-10th
- Hepatitis B: 3 doses over no less than a 4-month period
- Varicella: 2 doses after age 1 OR history of chicken pox illness
- Meningococcal(MCV4): 1 dose required after age 11 / 1 dose recommended after age 16

# WHICH SCHOOL SHOULD MY CHILD ATTEND? (ZONING)

# 2025-2026 AISD TRANSFER INFORMATION

Arlington ISD will have three transfer windows available for the 2025-2026 school year. All students who are offered a seat at Martin High School will be asked to provide attendance and discipline records from their prior campus for final transfer approval.

#### TRANSFER WINDOW DATES

- November 21 December 5, 2024 (Regular Transfer Window)
- March 25 April 17, 2025 (Special Transfer Window)
- July 1 17, 2025 (Special Transfer Window)

If your student is waitlisted, it is not necessary to re-apply during another transfer window. Applications from the second and third windows will be considered after those waitlisted from the first window.
