Subject: 2014 Bond Program Update – HUB Target

Purpose:

To update the Board on HUB participation in 2014 bond program construction projects and discuss the possibility of establishing a HUB target

Background:

Arlington ISD voters approved a bond proposition in the amount of \$663,130,000 on May 10, 2014. The proposition is a five-year capital plan that includes new construction, renovations and facility condition improvements along with capital purchases for technology, fine arts and transportation.

One hundred twenty construction projects are currently underway for phases I – IV of the bond program. Thirty-five projects are in close-out phase, 42 are in construction phase and 43 are in design, including the Fine Arts Center and Athletics Complex.

Participation of historically underutilized businesses (HUB) has been encouraged throughout the bond program. Contractor symposiums are held periodically to inform contractors and subcontractors about upcoming projects, bid notices are sent to all of the local chambers of commerce and points are awarded for HUB participation commitment in the selection of architects and contractors. Architects and contractors report their HUB participation to Plant Services each month when they submit pay applications. HUB commitments and actual participation are reported quarterly by staff to the Citizens Bond Oversight Committee and Board of Trustees, and the information is posted on the District's website.

The Administration will present an update on HUB participation in construction projects funded through the 2014 bond program.
