Subject: Consider the Schematic Design for Elementary School Playgrounds Project		

<u>Purpose</u>: To consider the Schematic Design for the 2019 Bond Program, Phase I, Bid Package 11, Elementary School Playgrounds renovations project

<u>Background</u>: Replacement and renovations for Elementary School Playgrounds was approved as part of the 2019 Bond Program. The District has developed plans to replace or renovate playgrounds at all elementary schools throughout the District to incorporate an equipment and surfacing standard and to ensure ADA access and equity for all campuses. Glenn Engineering was approved to provide engineering and design services for the project. Glenn Engineering developed the schematic design for the elementary school playgrounds using the District's established educational program and a series of three design charrette meetings held at the J.W. Counts Administration Building with teachers, principals, central administration, and the District's Facilities Planning and Construction team. Students at several elementary schools voted on the playground elements they desired for the final design.

District Administration will present the Schematic Design for Board review and approval. A representative from Glenn Engineering will be present to answer questions from the Board. With this approval, Phase I of the Elementary School Playgrounds replacement and renovations project is on schedule for substantial completion in fall 2021. Phases II and III will reach substantial completion in the fall of 2022 and 2023, respectively.

<u>Recommendation</u>: The Administration recommends approval of the schematic design for the Elementary School Playgrounds project as presented by District Administration and Glenn Engineering.
