Section 551.084 - For the purpose of excluding a witness or witnesses from a hearing during examination of another witness.

Should any final action, final decision or final vote be required in the opinion of the Board with regard to any matter considered in such closed meeting, then such final action, final decision or final vote shall be at either:

- A. the open meeting covered by this notice upon the reconvening of this public meeting, or
- B. at a subsequent public meeting of the Board upon notice thereof, as the Board shall determine.

Before any closed meeting is convened, the presiding officer will publicly identify the section or sections of the Act authorizing the closed meeting. All final votes, actions, or decisions will be taken in open meeting.

Purpose:

To update the Board on long-range financial planning for the general operating budget

Background:

Long-range financial planning is essential to ensure the District remains fiscally sound and uses resources effectively and efficiently to accomplish the District's goal that "100% of AISD students will graduate exceptionally prepared for college, career and citizenship." It is a best practice for all government entities. It is especially effective at identifying structural budget deficits and facilitating scenario analysis. Financial planning is a good fit with other long-range planning processes such as the District's strategic plan strategies, the school finance system, long-range facilities planning and information technology priorities.

The Administration will provide an update of the planning work for the general operating budget, including survey results and considerations of the possibility of a voter-approval tax rate election.

Subject: Consider Proposed 2020 Tax Rate for Revised Notice of Public Meeting to Discuss Budget and Proposed Tax Rate

<u>**Purpose</u>**: To provide the Board of Trustees an opportunity to vote on the proposed tax rate that will be posted in the Revised Notice of Public Meeting to Discuss Budget and Proposed Tax Rate for the 2020-21 Budget.</u>

Background: Texas Education Code 44.004 requires school districts to hold a public meeting to discuss the budget and proposed tax rate for the succeeding year, and to publish a "Notice of Public Meeting to Discuss Budget and Proposed Tax Rate" (Notice) at least 10, but not more than 30, days prior to that meeting. The public meeting must be held before the budget can be adopted.

The language and format of the notice is prescribed by the state Comptroller's office and must include both the proposed Maintenance & Operations tax rate and the proposed Debt Service tax rate. A school district may not adopt a tax rate that exceeds the proposed rate published in the notice. Should the Board desire to set a tax rate higher than that published in the original notice, the District would be required to publish a revised notice with the higher proposed tax rate and hold another public hearing to discuss the revised tax rate.

A public meeting was held on June 23, 2020, to discuss the District's fiscal year 2020-21 budget and proposed tax rate after posting the required notice of the meeting on June 13, 2020. The Board of Trustees adopted the budget on June 23rd, following the required public meeting. The 2020 tax rate is scheduled to be adopted by the Board on August 13, 2020.

District administration will present information to the Board about the District's 2020 certified property values and long-range financial needs. Actions to fund the budget and address long-range financial needs, including possibly calling a future tax ratification election, will be discussed. If the Board determines that it is necessary to consider adopting a tax rate higher than the rate published in the original notice published on June 13, 2020, a vote will be taken on the revised proposed rate and a public meeting to discuss the rate will be held on August 13th before the Board votes on the 2020 tax rate. A notice of the public meeting will be published in accordance with the provisions of Texas Education Code 44.004.

<u>Recommendation</u>: A formal vote on the proposed Maintenance & Operations and Debt Service tax rates that will be posted in the Revised Notice of Public Meeting to Discuss Budget and Proposed Tax Rate for the 2020-21 Budget is recommended.
