THAT ARLINGTON INDEPENDENT SCHOOL DISTRICT ("Grantor"), an independent school district, a local unit of government, duly organized and operating under the laws of the State of Texas, acting by and through Dr. Marcelo Cavazos, its Superintendent, does hereby convey, dedicate, set apart and reserve to the City of Arlington, a municipal corporation of Tarrant County, Texas, (hereafter, "City"), a temporary construction easement (hereafter, "Easement") upon, across, over and under that certain tract or parcel of land in Tarrant County, Texas, described as follows:

## SEE ATTACHED EXHIBIT "A" INCORPORATED HEREIN BY REFERENCE FOR ALL INTENTS AND PURPOSES

1. The Easement is for the public use of construction activities necessary to install a public water main, and other appurtenances (hereafter, "Improvements"). The City shall have the right to remove from the Easement any obstructions or encroachments which interfere with the City's use of the Easement.

2. The dedication, conveyance, and covenants herein are made in consideration of the benefits accruing to Grantor as the owner of certain adjacent property by reason of the Improvements, conditions, covenants and agreements herein set forth, and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged.

3. The Easement will become effective when construction commences on the property and shall cease upon the final acceptance of the construction project by the City. Property or expiration of the time period, whichever occurs first, at which time the easement shall terminate and all rights therein shall revert to the owners of the land.

4. This easement shall be construed according to the laws of the State of Texas.

TO HAVE AND TO HOLD the same unto the City of Arlington, its successors and assigns until completion.




