Subject: Instructional Materials and Technology Allotment and TEKS Certification, 2024-25

### Purpose:

To complete the annual TEKS certification process required to purchase instructional materials through the EMAT system utilizing funding provided through the Instructional Materials and Technology Allotment.

#### Background:

Materials adopted by the State Board of Education are eligible to be purchased through the EMAT system utilizing funds provided through the Instructional Materials and Technology Allotment (IMTA). This system opens annually for districts to order instructional materials for the upcoming school year. As part of this process, the Texas Education Code 31.1011 requires districts to certify to the State Board of Education (SBOE) and the commissioner of education that students have access to instructional materials that cover the Texas Essential Knowledge and Skills (TEKS) for all required subjects (with the exception of physical education) and that they protect against access to obscene or harmful content.

#### Recommendation:

Administration recommends that the TEKS certification form be approved as presented to meet statutory requirements for the purchase and acquisition of instructional materials utilizing Instructional Materials and Technology Allotment (IMTA) funds on the EMAT system.

## Survey Pre-Work

### 2024–25 Certification of Provision of Instructional Materials

In accordance with <u>Texas Education Code 31.1011</u>, local educational agencies (LEAs) are required to certify annually to the State Board of Education (SBOE) and the commissioner that students have access to instructional materials covering all Texas Essential Knowledge and Skills (TEKS) for all required subjects, except physical education.

Additionally, LEAs are required to certify that they protect against access to obscene or harmful content in compliance with the requirements for certification under (i) the Children's Internet Protection Act (Pub. L. No. 106-554); (ii) Section 28.0022; (iii) Section 43.22, Penal Code; and (iv) any other law or regulation that protects students from obscene or harmful content. The TEKS Certification 2024–25 Survey includes a section to allow LEAs to certify they meet this requirement.

Like last year's process, the agency will utilize the following tools:

#### Certification 2024-25 Form:

Printable, hard copy of the survey to be completed offline and presented to the board of trustees or governing body for ratification and signatures.

## Certification 2024–25 Survey:

Web-based application where LEAs will submit their responses collected on the TEKS Certification 2024–25 Form, and where LEAs will upload the signature page of the Form.

This year's Certification Process requires:

- The completion of the Certification 2024–25 Form;
- Ratification by the LEA's board of trustees or governing body in an open, public-noticed meeting;
   and
- Submission of the Certification 2024–25 Survey and upload of the ratified Certification 2024–25 Form.

TEA recommends that LEAs complete these steps by **May 1, 2024**. The Certification 2024–25 Form can be accessed at the following link on the <u>Instructional Materials webpage</u>.

The state online instructional materials ordering system, EMAT, will close for annual maintenance on March 29, 2024, and is scheduled to reopen on May 15, 2024. <u>Completion of the Certification Process</u> is required to regain access to allotment funds when EMAT reopens in May of 2024.

Certification 2024–25 Survey submissions received after May 15, 2024, will typically be processed within five business days, then access to EMAT provided.

## Instructions to Complete the Certification Process for 2024–25

- 1. **Review the Certification 2024–25 Form**: Print the fillable TEKS Certification 2024–25 Form found on the Instructional Materials website.
- 2. **Gather information:** The form may require consultation with content area leads or other LEA staff.
- 3. **Complete Certification 2024–25 Form**: Complete the TEKS Certification 2024–25 Form by hand or digitally.
- 4. **Obtain needed signatures**: Ratify the **Certification 2024–25 Form** by the LEA's board of trustees or governing body in an upcoming, open board meeting.
- 5. **Submit Certification 2024–25 Survey**: Complete the online Certification 2024–25 Survey by answering the questions. Inside the survey you will upload the signed Allotment and Certification 2024–25 Form from Step 4. The survey will be open for submissions beginning Monday, March 18, 2024, and will be located on the <u>Instructional Materials website</u>.

The district also provides additional retirement savings options for all employees in the form of 457(b) plans. This is in addition to the Texas Teacher Retirement System (TRS).

The district engages with TCG for the administration of a FICA Alternative Plan. The district engages with Redwood Financial for the administration of 457(b) plans. The district is seeking one provider who can offer both of these services (FICA Alternative and 457(b) plans) to our employee population.

Proposals for the consolidated services were received from seven (7) vendors: Redwood Financial, Equitable Financial, National Benefits Services, IPX Retirement, TCG Group Holdings, National Life Group, and Applied Magnets. Employees who are in the medical plan are automatically enrolled in the wellness plan. Members earn points for the completion of wellness activities. Medically enrolled employees who reach a certain point status receive an additional \$51 monthly wellness credit. The wellness plan is a vital part of our overall benefits program and has offered health education, fitness tracking, plans to get active, health screenings, healthy eating, improving sleep, etc.

<u>Background</u>: The District is making renovations to Amos Elementary School and Oncor Electric Delivery Company, LLC, requires an easement and right-of-way for underground electric supply lines, consisting of a variable number of wires and cables, surface mounted equipment, conduits, manholes, vaults, transformers, switches, switchgears, auto-transformers, protection, sectionalizing devices and all necessary or desirable appurtenances over, under, across and upon the subject property.

Grantor recognizes that the general course of said lines, or the metes and bounds as described above, is based on preliminary surveys only, and Grantor hereby agrees that the easement and right-of-way and its general dimensions hereby granted shall apply to the actual location of said lines when constructed.

Together with the right of ingress and egress along and upon said easement and rightof-way and over and across Grantor's adjoining properties for the purpose of and with the right to construct, maintain, operate, repair, remove, replace, reconstruct, abandon in place, and to change the size and capacity of said facilities; the right to relocate said facilities in the same relative direction of said facilities; the right to relocate said facilities in the same relative position to any adjacent road if and as such is widened in the future; the right to lease wire space for the purpose of permitting others to string or lay wire or cable along said facilities; the right to prevent excavation within the easement area; the right to prevent construction of, within the easement area, any and all buildings, structures or other obstructions which, in the sole judgment of Grantee, may endanger or interfere with the efficiency, safety, and/or convenient operation of said facilities and their appurtenances and the right to trim or remove trees or shrubbery within, but not limited to, said easement area, including by use of herbicides or other similar chemicals approved by the U.S. Environmental Protection Agency, to the extent in the sole judgment of Grantee, as may be necessary to prevent possible interference with the operation of said facilities or to remove possible hazard thereto. Grantor shall not make changes in grade, elevation or contour of the land or impound water within the easement area as described above without prior written consent of Grantee.

Grantor reserves the right to use the land within the above described easement area for purposes not inconsistent with Grantee's use of such property, provided such use shall not, in the sole judgment of Grantee, interfere with the exercise by Grantee of the rights hereby granted.

TO HAVE AND TO HOLD the above described easement and right-of-way unto the said Grantee, its successors and assigns, until all of said electric lines and facilities shall be abandoned, and in that event said easement and right-of-way shall cease and all rights herein granted shall terminate and revert to Grantor or Grantor's heirs, successors or assigns, and legal representatives; and Grantor hereby binds Grantor and Grantor's heirs, successors, assigns, and legal representatives, to warrant and forever defend the above described easement and right-of-way unto Grantee, its successors and assigns, against every person whomsoever lawfully claiming or to claim the same or any part thereof.



Subject: House Bill 3 and District Improvement Plan Progress Update

## Purpose:

To provide the Board with progress update pertaining to House Bill 3 (HB 3) and District Improvement Plan (DIP) goals/targets in alignment with the Board adopted monitoring calendar.

# Background:

In the spring of 2019, the 86<sup>th</sup> Legislature passed the finance bill, House Bill 3 (HB 3), which included specific requirements pertaining to goal setting and the progress monitoring process for improved outcomes in early childhood literacy and mathematics, as well as college, career, and military readiness (CCMR). The statute requires school boards to adopt plans that include annual goals for aggregate growth on 3<sup>rd</sup> grade reading and mathematics achievement, annual targets for closing achievement gaps among student groups, targeted professional development for classroom teachers and annual targets for students being served in bilingual and ESL programs. The bill also calls for aggregate annual goals and targets for CCMR readiness as evaluated under the state accountability system's student achievement domain and for each student group articulated in the closing the gaps domain. Additionally, the Board adopts annual performance objectives to be included in the District Improvement Plan (DIP).

This discussion item will provide a progress update pertaining to student outcomes on the benchmark assessments and other areas as they relate to HB 3 and DIP goals/targets.
