#### Purpose:

To consider adoption of an ordinance setting the 2024 tax rate.

#### Background:

Based on the 2024 property values certified by Tarrant Appraisal District as of July 25, 2024 and the Maximum Compressed Rate (MCR) determined by the Texas Education Agency, administration proposes a tax rate of \$ 0.8128 for Maintenance and Operations (M&O) and \$0.2907 for Interest and Sinking (I&S), for an overall total rate of \$1.1035 per \$100 valuation.

The total tax rate of \$1.1035 is \$0.0121 less than the 2023 tax rate and less than the tax rate advertised on the Notice of Public Hearing published on June 7, 2024.







# AN ORDINANCE MAKING THE TAX LEVY FOR THE YEAR 2024 ON ALL PROPERTY SUBJECT TO TAXATION SITUATED WITHIN THE ARLINGTON INDEPENDENT SCHOOL DISTRICT:

# BE IT ORDAINED BY THE BOARD OF TRUSTEES OF THE ARLINGTON INDEPENDENT SCHOOL DISTRICT:

THAT for the year 2024 there is hereby levied on all property located within the corporate limits of the ARLINGTON INDEPENDENT SCHOOL DISTRICT on the first day of January 2024 and not exempt from taxation by the Constitution and Laws of the State of Texas, an ad valorem tax of \$1.1035 on each and every \$100 valuation of such property apportioned as follows:

- (A) \$0.8128 on each and every \$100 valuation of such property is hereby levied and assessed to pay for the operation and maintenance of public free schools of the said ARLINGTON INDEPENDENT SCHOOL DISTRICT.
- (B) \$0.2907 on each and every \$100 valuation of such property is hereby levied and assessed to pay current interest and provide a fixed fund for payment of bonds issued by the said ARLINGTON INDEPENDENT SCHOOL DISTRICT.

**GENERAL INFORMATION:** Tax Code Section 26.04(c) requires an officer or employee designated by the governing body to calculate the no-new-revenue tax rate and voterapproval tax rate for the taxing unit. These tax rates are expressed in dollars per \$100 of taxable value calculated. The calculation process starts after the chief appraiser delivers to the taxing unit the certified appraisal roll or certified estimate of value and the estimated values of properties under protest. The designated officer or employee shall submit the rates to the governing body by August 7 or as soon thereafter as practicable. Tax Code Section 26.04(e-1) does not require school districts to certify tax rate calculations or comply with certain Tax Code notice requirements. School districts are required to provide notice regarding tax rate calculations pursuant to Education Code Chapter 44.

This worksheet is for school districts without Chapter 313 agreements only. School districts that have a Chapter 313 agreement should use Comptroller Form 50-884 Tax Rate Calculation Worksheet, School Districts with Chapter 313 Agreements.

Water districts as defined under Water Code Section 49.001(1) do not use this form. Use Comptroller Form 50-858 Water District Voter-Approval Tax Rate Worksheet for Low Tax Rate and Developing Districts or Comptroller Form 50-860 Developed Water District Voter-Approval Tax Rate Worksheet.

All other taxing units should use Comptroller Form 50-856 Tax Rate Calculation, Taxing Units Other Than School Districts or Water Districts.

The Comptroller's office provides this worksheet to assist taxing units in determining tax rates. #### SECTION 2: Voter-Approval Tax Rate

The voter-approval tax rate is the highest tax rate that a taxing unit may adopt without holding an election to seek voter approval of the rate. Most school districts calculate a voter-approval tax rate that is split into three separate rates. <sup>1</sup>

- 1. Maximum Compressed Tax Rate (MCR): A district's maximum compressed tax rate is defined as the tax rate for the current tax year per \$100 of valuation of taxable property at which the district must levy a maintenance and operations tax to receive the full amount of the tier one allotment.<sup>19</sup>
- 2. Enrichment Tax Rate: 20 A district's enrichment tax rate is defined as any tax effort in excess of the district's MCR and less than \$0.17. The enrichment tax rate is divided into golden pennies and copper pennies. School districts can claim up to 8 golden pennies, not subject to compression, and 9 copper pennies which are subject to compression with any increases in the guaranteed yield. 21
- 3. Debt Rate: The debt rate includes the debt service necessary to pay the school district's debt payments in the coming year. This rate accounts for principal and interest on bonds and other debt secured by property tax revenue.

The MCR and Enrichment Tax Rate added together make up the school district's maintenance and operations (M&O) tax rate. Districts cannot increase the district's M&O tax rate to create a surplus in M&O tax revenue for the purpose of paying the district's debt service. 22

If a school district adopted a tax rate that exceeded its voter-approval tax rate without holding an election to respond to a disaster in the prior year, as allowed by Tax Code Section 26.042(e), the school district may not consider the amount by which it exceeded its voter-approval tax rate (disaster pennies) in the calculation this year. This adjustment will be made in Section 4 of this worksheet.

A district must complete an efficiency audit before seeking voter approval to adopt a M&O tax rate higher than the calculated M&O tax rate, hold an open meeting to discuss the results of the audit, and post the results of the audit on the district's website 30 days prior to the election. 23 Additionally, a school district located in an area declared a disaster by the governor may adopt a M&O tax rate higher than the calculated M&O tax rate during the two-year period following the date of the declaration without conducting an efficiency audit. 24

# Purpose:

The administration is seeking approval to apply for the Staff Development Minutes Waiver allowable under the provision of Texas Education Code (TEC) §7.056.

### Background:

Per the Texas Education Agency website, the Staff Development Minutes Waiver, "...allows districts and charter schools to train staff on various educational strategies designed to improve student performance in lieu of student instruction during the school year. Effective with the 2018-2019 school year, the *Staff Development Minutes Waiver* provides for a maximum of 2,100 total waiver minutes to use for professional development for districts and charter schools that provide operational and instructional minutes."

According to TEA's State Waiver Guidebook for 2024-25, the district can request waivers for up to a total of 4,200 instructional minutes.

The 2024-25 district calendar provides for the state requirement of 187 days of teacher contract, which includes 174 instructional days and 13 non-teaching days and has historically provided sufficient time for staff development for our teachers.

Some districts, including Arlington ISD, have applied for the Staff Development Minutes Waiver as a 'safety net' in the event that an emergency requires the use of student instructional minutes for staff development.

# Arlington Independent School District Board Resolution

**BE IT RESOLVED**, that the Arlington Independent School District Board of Trustees disapproves of the 2025-2026 Tarrant Appraisal District Reappraisal Plan submitted by the Tarrant Appraisal District Board of Directors.

WHEREAS, Texas Tax Code § 6.01(b) establishes the county appraisal district's responsibility to appraise property in their district for ad valorem tax purposes of each taxing unit; and

WHEREAS, Texas Tax Code § 6.23(b) establishes that it is the duty of the assessor and collector to assess and collect taxes; and

WHEREAS, Texas Tax Code § 23.01 requires that all taxable property is appraised at its market value as of January 1; and

WHEREAS, Texas Tax Code § 1.04(7) defines "Market value" to mean the price at which a property would transfer under prevailing market conditions; and

WHEREAS, the Reappraisal Plan freezes residential property values for 2025 to the 2024 values and does not require reappraisal until 2027, making it impossible to accurately appraise residential property for prevailing market conditions on January 1, 2025 and January 1, 2026; and

WHEREAS, a three-year freeze on residential property values in Tarrant County cannot accurately reflect the prevailing market conditions and property value growth in Tarrant County; and

WHEREAS, the Reappraisal Plan will negatively affect funding to public school districts due to the methods used by the State of Texas to calculate public school funding; and

WHEREAS, the Reappraisal Plan will likely harm Arlington Independent School District and Tarrant County public schools because they may not receive full funding on the years the residential properties are not reappraised using prevailing market conditions; and

WHEREAS, the Reappraisal Plan will ultimately harm Arlington Independent School District's maintenance & operations budget and its interest & sinking budget, likely requiring the District to reduce programs and educational opportunities to students; and

WHEREAS, the TAD Board of Directors removed specific verbiage from the Reappraisal Plan which was recommended by the Chief Appraiser and would have helped to protect the funding of public school districts; and

WHEREAS, members of the TAD Board of Directors, acting in their official capacity, publicly stated their understanding of school finance, and explicitly denied opportunity for parties

knowledgeable about the intricacies of school finance in Texas to correct or clarify errors or misinterpretations; and

WHEREAS, the TAD Board of Directors failed to address the concerns that school districts expressed about the impact the Reappraisal Plan would have on public school funding; and

**NOW, THEREFORE, BE IT FURTHER RESOLVED**, that the Arlington Independent school District strongly disapproves of the Tarrant Appraisal District's 2025-2026 Reappraisal Plan, as adopted on August 9, 2024; and

WHEREAS, Arlington Independent School District is a taxing entity within the Tarrant Appraisal District and relies on the Tarrant Appraisal District for appraising property within the boundaries of the county for ad valorem tax purposes; and

WHEREAS, the Tarrant Appraisal District operations are funded solely by the local taxing entities served by the appraisal district, which includes Arlington Independent School District; and

WHEREAS, on August 9, 2024, the Tarrant Appraisal District Board of Directors voted to approve its 2025 Budget in the amount of \$33,585,297, an increase of 14.12% from the current 2024 budget; and

WHEREAS, Arlington Independent School District's portion of Tarrant Appraisal District's budget has increased from \$2,163,317.56 in 2024 to an estimated amount of \$ 2,463,175.84 in 2025; and

WHEREAS, the Tarrant Appraisal District Board of Directors also recently adopted an Appraisal Plan that will result in the Tarrant Appraisal District performing less services in the coming years; and

WHEREAS, pursuant to Texas Property Tax Code section 6.06(b), Arlington Independent School District has a right to adopt a resolution disapproving the Tarrant Appraisal District budget; and

WHEREAS, pursuant to Texas Property Tax Code section 6.06(b), Arlington Independent School District encourages the majority of the taxing units entitled to vote on the appointment of board members adopt resolutions disapproving a budget and file them with the secretary of the board within 30 days after its adoption.

NOW, THEREFORE, BE IT RESOLVED, the Arlington Independent School District Board of Trustees disapproves of the Tarrant Appraisal District 2025 Budget, and
