ORDER CALLING A VOTER-APPROVAL TAX RATE SPECIAL ELECTION

WHEREAS, the Board of Trustees of the Arlington Independent School District (the "District") deems it advisable to call the Voter-Approval Tax Rate special election hereinafter ordered; and

WHEREAS, it is hereby officially found and determined that the meeting at which this Order was adopted was open to the public, and public notice of the time, place, and purpose of the meeting was given, all as required by the Texas Government Code, Chapter 551.

THEREFORE, BE IT ORDERED BY THE BOARD OF TRUSTEES OF ARLINGTON INDEPENDENT SCHOOL DISTRICT:

1. A Voter-Approval Tax Rate Election shall be held between the hours of 7:00 A.M. and 7:00 P.M. on November 3, 2020, in the District at the designated polling places for registered voters of the District.

2. Early Voting by personal appearance will be conducted at the main early voting polling location and other locations designated by the Tarrant County Election Administration, Tarrant County Election Center, 2700 Premier Street, Fort Worth, TX 76111. Days and hours of early voting shall be:

October 13-17, Tuesday-Saturday, 8:00 a.m. – 5:00 p.m.

October 19-23, Monday-Friday, 8:00 a.m. – 5:00 p.m.

October 24, Saturday, 7:00 a.m. – 7:00 p.m.

October 25, Sunday, 11:00 a.m. – 4:00 p.m.

October 26-30, Monday-Friday, 7:00 a.m. – 7:00 p.m.

3. Eligible voters who live in the District may vote on Election Day and during the period for early voting at the places and times for voting during the early voting period, being October 13, 2020 through October 30, 2020 as established by Tarrant County Election Administration.

4. The Tarrant County Elections Administrator shall serve as the early voting clerk in accordance with the terms of an Election Services Agreement.

5. Applications for early voting by mail for all residents of the District shall be sent to:

6. All resident, qualified electors of the District shall be entitled to vote at the election.

Ratifying the ad valorem tax rate of \$1.3871 in Arlington Independent School District for the current year, a rate that will result in an increase of 12.42 percent in maintenance and operations tax revenue for the district for the current year as compared to the preceding year, which is an additional \$35,901,060.
