you have information on what you want or need to help you achieve your goals, activities can be created to help you make progress towards those goals.

<u>For example</u>, if your plan is to attend a college to earn a degree, here are some activities you should choose to work towards that goal.

- Meet with your counselor to make sure the courses you take will meet college requirements or prepare you for your career.
- Determine what you want from a college. (i.e., types of programs, distance from home, size of campus, cost)
- Pass the STAAR test.
- Research colleges that have degrees in areas of your interest.
- Research college admissions requirements.
- Visit the colleges of interest.
- Research scholarship opportunities.

- ◆ Take the PSAT (in 10<sup>th</sup> grade) and SAT or ACT (in 11<sup>th</sup> and 12<sup>th</sup> grade) or other required test.
- Complete a Free Application for Federal Student Aid (FAFSA) and Texas Application for State Financial Aid (TASFA).
- Complete admissions applications for colleges and send them to your schools of interest before their deadlines.
- Determine if you will be living off-campus (with family or in an apartment) or in a dorm. Research apartments and dorms accordingly. Submit applications in a timely manner.

As you can see, there are many activities that must be accomplished in order to meet this one goal. Planning which activities you will accomplish first will help you stay focused and headed in the right direction. Use the example goal/activity box below to help you identify your goals and create activities. More boxes are located in the appendix (at the back).

Below is an example of a work goal and activities for a 9<sup>th</sup> grade student.

Goal: After graduating from high school, I will work as a police officer or as a teacher. Activity: Research career information and requirements for police officers and teachers online. Activity: Research colleges that train future police officers and teachers.

Activity: Research information on classes available through the district for persons interested in those fields (e.g., Ready, Set, Teach I & II or Intro to Criminal Justice, Fundamentals of Criminal Law and Crime in America).

<u>Activity</u>: Speak to your counselor about taking classes to prepare for a career and/or college.

Job Corps is a no-cost education and vocational training program administered by the US Department of Labor that helps young people 16 through 24 get a better job, make more money and take control of their lives.

At Job Corps students enroll to learn a trade, earn a high school diploma or GED or get help finding a good job. Individuals who join the program are paid a monthly allowance; the longer an individual stays with the program, the more he/she earns as an allowance. Job Corps provides career counseling and transition support to students for up to 12 months after they graduate from the program.

There are 4 Job Corps facilities in Texas, located in El Paso, McKinney, San Marcos and Laredo. Students live on campus and must meet strict guidelines. For specific information on applying, visit the website or call the local office.

# EDUCATIONAL RESOURCES

#### **Disability Support Services**

Supports for persons with disabilities at the college level may be available. Colleges that receive federal funds must have an office that assists persons with disabilities in accessing the programs that are available.

Supports may include providing:

- Interpreters
- Testing accommodations
- Note taking accommodations
- Technology assistance
- Mobility assistance
- Tutoring

Colleges will **NOT** do the following:

- Accept accommodations recommended from public school IEPs
- Reduce your assignments
- Reduce or modify your tests

# A VERY IMPORTANT NOTE! - <u>The schools will not modify or alter the</u> <u>curriculum for anyone</u>. However, they may accommodate.

#### **Universities/Colleges**

- Private and public available
- Degrees earned in 4-5 years
- Costs vary, private typically more expensive
- Small and large colleges are available
- Degrees include bachelors and may include masters and doctorate degree plans
- Admissions requirements fairly standard
  - High school diploma or GED
  - SAT/ACT tests required
  - Applications need to be submitted with letters of recommendation and essay

#### Junior College

- Private and public available
- Programs completed in 1-3 years typically depending on program
- Costs vary, private typically more expensive
- Small and large colleges are available
- Certificates, licenses and associates degrees available
- Admissions requirements standard
  - Application required
  - A test will likely be required (TSI approved exam in Texas)

#### **Trade/Technical Schools**

- Private and state schools available
- Programs completed in 2-3 years typically
- Costs vary, private typically more expensive
- Both small and large schools available
- Some schools specialize in one area while others offer many programs
- Admissions requirements are fairly standard
  - Application required
  - Interview may be required
  - A test will be required (it may consist of a TSI approved exam or a specialized test for the individual school)

#### **Apprenticeships**

- Learn to become a skilled laborer in a trade of interest while working
- Timeline depends on skills being taught and certification desired
- Earn money while you learn
- Some classroom instruction will be required as part of the training
- Admission into a program is standard
  - Identify a trade you want training in
  - Locate an employer that is willing to hire you and will train you to become skilled in that trade.
  - Register to become an apprentice with the United States Department of Labor Office of Apprenticeship.

#### Military

- Signing bonuses may be available.
- If you are in ROTC for 4 years in high school, you may get a higher wage once enlisted.
- If you earn a degree or certification before enlisting, your wage may also be increased.
- If you enlist after graduation from high school, you can have money saved to put towards your education after your tour of duty has been completed.
- If interested in a specific branch, it is highly advised that you speak to a recruiter.
- Enlistment requirements are standard
  - Graduate from high school
  - Apply for enlistment
  - Take ASVAB test
  - Pass a physical

#### **Determining What Classes to Take in High School**

A key step to planning for the future is taking courses in high school that may prepare you for your career. Whenever possible, take electives and/or required courses that will expose you to topics or skills needed in your areas of interest. Please, utilize resources and information on courses offered by your district (ex. course description handbook, counselor)

#### **College Preparation Checklist**

8<sup>th</sup> Grade

- □ Think about your area of interest then match it with available high school courses.
- □ You and your parents are encouraged to participate in ARD meetings to discuss next year's schedule.
- Meet with your counselor to review four-year plans and discuss preliminary college plans.

#### 9<sup>th</sup> Grade

- □ Continue to evaluate goals and objectives.
- □ Consider registering for and taking PSAT in October.
- □ Review college catalogs and begin to match high school courses with what is required for college admission.
- □ You and your parents are encouraged to participate in ARD meetings to discuss next year's schedule.
- □ Continue to review college catalog profiles.
- Meet with your counselor to review four-year plans, discuss preliminary college plans, and determine if accommodations will be requested for SAT, ACT, and TSI approved tests.

#### 10<sup>th</sup> Grade

- □ Attend college night in the Fall\*.
- □ Register for and take the PSAT in October.
- □ Meet with counselor to analyze PSAT results.
- □ Begin to refine college choices and college admission requirements.

□ Review four-year plan and match courses with those required for specific college admission.

- □ You and your parents are encouraged to participate in ARD meetings to discuss junior course selections.
- □ Review your written goals for life after school. Make changes based on your current interests and skills.

#### 11<sup>th</sup> Grade

- □ Attend college night in the Fall\*.
- □ You and your parents are encouraged to participate in ARD meetings to discuss senior course selections.
- □ Take SAT / ACT/ TSI approved exam\*\* in the Spring.
- □ Visit colleges complete early applications as needed.
- □ Apply for any scholarships that require early submission according to deadlines.
- □ Review four-year plan and match senior courses with those needed for college admission.

#### 12<sup>th</sup> Grade

- □ Attend college night in the Fall\*.
- □ Register for the correct college entrance examination (SAT/ACT/ TSI approved exam\*\*) especially if you did not take it as a junior.
- □ Finalize college choices pay close attention to deadline dates.
- □ Give letter of recommendation requests to all persons involved at least 3 weeks ahead of deadline dates.
- □ Attend college campus visitation weekends.
- □ Make formal applications to colleges.
- □ Apply for college and local scholarships in a timely manner to meet appropriate due dates.
- □ Make dorm reservations as required.
- Apply for financial aid before February 1<sup>st</sup>, FAFSA application opens October 1<sup>st</sup>.
- □ Inform counselor where final transcript is to be sent.
- □ You are encouraged to participate in ARD meetings to discuss transition IEP goals and progress.
- \* See your counselor for specific dates and times.
- \*\* TSI approved exam or a similar placement test is required at all public colleges in Texas. See your counselor for more information.

#### Senior Year Tests for College Admission

- ACT The ACT Assessment is designed to assess high school students' general educational development and their ability to complete college-level work. The test covers four skill areas: English, mathematics, reading and science reasoning. Their website is <u>www.act.org</u>.
- **<u>ASVAB</u>** Armed Services Vocational Aptitude Battery test used for admission into the armed services. Every job in the military has minimum ASVAB scores in one or more sections of the test. Higher scores lead to more job options.
- **<u>SAT</u>** The SAT is used as a standard way of measuring a student's ability to do college-level work. The test measures verbal and math reasoning abilities. Their website is <u>www.collegeboard.com</u>.
- **TSI** If you are an incoming college student in Texas, you are required to take the TSI Assessment unless you are already exempt. Access the following website for more information: <u>www.collegeforalltexans.com</u>

Contact the college/university at which you plan to take the test for details on dates/times to complete this mandatory Pre-Assessment Activity. You must participate in a Pre-Assessment Activity before you take the TSI Assessment. The college/university at which you take your test is required to provide the Pre-Assessment Activity as well as document your participation.

#### **Testing Accommodations**

If you need to take the SAT, ACT or TSI (in Texas only) test for admission into a school and you feel you may need accommodations for the test, you must apply for those accommodations, with the assistance of your school counselor. Documentation concerning your disability and needs will be required. See the following websites for specific information.

**AN IMPORTANT NOTE!** If you don't request accommodations the first time you take the test, you cannot request the accommodations if you decide to take the test again.

To receive disability support services, you must establish eligibility with that college. All colleges will require you to submit documentation.

Medicaid waivers allow the state to be more flexible in how it spends money to provide some long-term services to some people with disabilities or elderly citizens who are eligible for Medicaid. Waivers override certain rules for how that funding can be used. Now, if eligibility requirements are met, people can receive the services they need in their own homes or other community settings. In Texas, there are several different waiver programs that offer a broad range of home and community-based services. There are different rules and funding amounts associated with each of the different waivers. In general, though, they all help people with disabilities or elderly citizens obtain the supports they need.

Applicants are placed on the interest lists on a first-come, first-served basis. When a person's name comes to the top of the lists, he or she will be contacted by a caseworker to determine eligibility. The wait time to be contacted by a caseworker can be up to 13 years. <u>Therefore, individuals</u> are strongly encouraged to place their names on the interest lists as <u>soon as possible</u>. #### Q: Who is eligible?

- A: Individuals who have:

  - Bipolar Disorders
  - Schizophrenia
  - And other serious mental illness

#### Q: What Do These Services Cost?

# <u>Guardianship</u>

#### REGARDLESS OF A PERSON'S DISABILITY, WHEN THAT PERSON TURNS 18, THEY ARE CONSIDERED A LEGAL ADULT.

What this means is, the person has the right to enter into contracts, make decisions without needing consent from another person, etc. <u>Texas laws</u> <u>permit another person to petition for guardianship of someone who</u> <u>may not be able to make decisions for themselves</u>.

To do this, the individual seeking the petition will need to go to court. He/she could hire a lawyer, or possibly petition directly to the courts in some cases.

The process cannot begin until the person is almost 18. Whether you represent yourself or hire a lawyer, the courts will assign a lawyer to the person from whom you are trying to get guardianship. They will take the stance of protecting the rights of that person. You or your lawyer, with input from a court investigator, will argue whether there is justification for taking over the decision-making rights of the person.

The process may take weeks or even months, so one must prepare in advance if they wish to seek guardianship.

# Special Needs Trust / SSI Spotlight On Trusts

#### Q: What is a trust?

A: A trust is a legal arrangement regulated by state law in which one party holds property for the benefit of another. A trust can be set up for an SSI beneficiary. A trust can contain cash, other liquid assets, real estate or personal property that could be turned into cash.

# Q: Can a trust be set up to give an SSI beneficiary more financial independence?

A: Yes. This type of trust is one where the SSI beneficiary does not have the legal authority to control how the money is spent, and a trustee manages the trust and decides how to spend the money to meet the person's needs.

#### **Q:** How do resources in this type of trust count in the SSI program?

A: Money or property in this type of trust for a SSI beneficiary (or person whose resources are deemed available to a SSI beneficiary) does not count toward the SSI resource limits of \$2,000 for an individual (or \$3,000 for a couple).

NOTE: Some trusts, which are not counted as resources for SSI purposes, may affect Medicaid eligibility. In these cases, the State will determine Medicaid eligibility.

# Q: How does money from the trust affect the individual's SSI payments?

A: Money paid directly to the provider for items other than the person's food, clothing, and shelter does not reduce SSI payments. Items that are not "food, clothing, or shelter" include medical care, telephone bills, education and entertainment.

#### Q: How can you find out more about setting up a trust? A:

- 1. Consult a lawyer or financial advisor to find out more about trusts.
- 2. Your local Social Security office has a list of groups that can find you a lawyer or give you free legal services, if you qualify.
- 3. You may also contact the state or local bar association or the Legal Services Corporation for legal assistance, if you qualify.
- 4. You can contact your local bank to set up a Special Needs Trust account.

This website may be of great benefit to you if you are not able to work due to a handicapping condition. Eligibility is based on the parents' income until the person with the disability turns 18. At that point, eligibility is based on your income. If you are determined to be eligible, you will receive a check for a particular amount dependent upon the need. More importantly, the state of Texas will issue Medicaid coverage at that point. This is medical coverage that will aid you as long as you qualify. To stay eligible, you must not have more than \$2,000.00 in your name. For more information on SSI, please research information at the websites <u>www.ssa.gov/benefits/disability/</u>

#### TexCare Partnership

#### **Q:** What is TexCare Partnership?

A: TexCare Partnership is a children's health insurance campaign developed especially for Texas families. Its purpose is to provide health insurance for children at a price that fits the budgets of Texas families.

#### Q: Who qualifies?

A: Uninsured children newborn through age 19. The child must be a Texas resident and a U.S. citizen. The TexCare Partnership offers

three separate health insurance programs for children: Children's Medicaid, Children's Health Insurance Program (CHIP) and CHIP Perinatal which is for Texas residents who are pregnant, uninsured and not eligible for Medicaid.).

Each program has its own set of rules and benefits package for qualifying children. You can find out which program your child may qualify for with one phone call, or by completing one simple application. Parents do not have to be a US citizen to apply.

#### Q: What is covered?

A: Benefits include doctor visits for dental, mental health and medical services such as regular check-ups, immunizations, x-rays, hearing and vision tests. Emergency care, hospital stays, surgery and services for children with disabilities and special health care needs will be covered. For CHIP Perinatal, benefits include up to 20 prenatal visits, prescription drug coverage based on formulary, hospital facility charges and two post partum visits for the mother.

#### Q: What do I pay?

A: Rates are flexible and are based on the number of people in your family and your family's income and expenses. You can call the TexCare partnership today to find out exactly how much it will cost to insure your children.

#### Q: How do I apply?

# Driver's License

Students can take driver's education in a number of ways.

- School districts often have courses on their campuses. Some districts offer the class only in the summer. Others have them throughout the school year.
- Businesses can provide driver's education throughout the year. The costs vary from business to business, so it is wise to call several local or available businesses that can provide this service.

◆ Parents can now act as the instructor for a driver's education program. The Texas Department of Public Safety has information about what the parents' role will be in this program and how to enroll. The information can be found at <u>www.tdlr.texas.gov/</u>

# Selective Service

Registering is important to the future of young men and the country.

#### Q: What is Selective Service?

A: The Selective Service System is a government agency. The system's job is to provide men for service in the Armed Forces in case of a national emergency.

#### Q: What is Selective Service Registration?

A: When you register, you add your name to a list of all men in the nation, ages 18 through 25. The list would be used to identify men for possible military service in a national emergency.

#### Q: What happens if there is a draft?

A: There has not been a draft since 1973, but if there were an emergency, and Congress ordered another draft, Selective Services would conduct a birthday lottery to decide the order in which to call men. Men who turn 20 in that calendar year would be called first in a sequence determined by the lottery. If more men were needed, those 21 to 25 might be called, youngest first. At that point, men will be evaluated for mental, physical and moral fitness which would determine their status, be it inducted into the military or deferred or exempted from service. For more information on who must register, please refer to the following website, <u>www.sss.gov</u>

#### Q: Am I required to register?

A: Yes, it is the law. If you do not register and are prosecuted, you could go to jail for up to five years and you can be fined up to \$250,000. Not registering hurts you in other ways also. You cannot qualify for federal student grants or loans, job training benefits or most federal employment.

#### Q: Is registration hard?

A: No, it is simple. Just go to any post office and ask for a *Selective Service Registration Card*. Fill in your name, address, telephone number, date of birth and Social Security Number. Then, give the card to the postal clerk (postage is required); they may ask for identification, so bring your driver's license or some other form of identification. It only takes about five minutes.

#### Q: Do I have to register at a post office?

A: Maybe not. You may receive a registration card in the mail. Simply fill it out and mail it. Also, check with your school's guidance office. You may be able to register there. You may also register on-line at <u>www.sss.gov</u>. If you wish, you may call 847-688-6888.

#### Q: When should I register?

A: 30 days prior of your 18<sup>th</sup> birthday or following 29 days after. If you are applying for federal student aid or job training, you can register up to 120 days before you turn 18 to avoid delays. If you cannot register on time because you are in a hospital or prison, you do not have to register until you are released. Upon release or discharge, you have 30 days to register.

# Q: What if it is more than 30 days after I have turned 18 and I have not registered?

A: Register at a post office or on-line immediately. Selective Service will accept a late registration, but the longer you wait, the longer you are breaking the law.

#### Q: Do all men have to register?

A: The law requires all 18 year old men to register. The only young men exempt from registration are foreigners who are in the U.S. temporarily as tourists, diplomats or students, men on active duty in the Armed Forces and students at U.S. military academies. Immigrant non-citizen males, 18-25, must register.

#### Q: How do I prove I registered?

A: After you register, Selective Service will mail you a card. Keep it as proof that you have registered. You may need it if you apply for federal employment, federal student aid or job training. If you do not get your card within 90 days of registering, write to: Registration Information Office, P.O. Box 94638, Palatime, IL 60094-4638 or call 847-688-6888.

#### Q: What if I change my address?

A: Notify Selective Service of your new address on a *Change of Information* form. You can get one at any post office or you can use the *Change of Address* form that comes with your acknowledgement card.

The registration form can be obtained at the local post office or you can register on-line at <u>www.sss.gov</u>. To confirm registration or get a new card, call 847-688-6888.

# Voter Registration

To be eligible to register to vote in Texas, you must:

- Be a U.S. citizen
- Be a resident of the county in which you are registering
- Be 18 years old (you may register at 17 years and 10 months)
- Not be a convicted felon (unless a person's sentence is completed, including any probation or parole)
- Not be declared mentally incapacitated by a court of law
